4. First-aid measures

5. Fire-fighting measures

6. Accidental release measures

Personal precautions, protective equipment and emergency procedures: Keep unauthorized personnel away. Keep upwind. Use personal protective equipment. Methods and material for containment and cleaning up: Neutralize with lime or soda ash. Neutralize spill area and washings with dilute acetic acid. Absorb spill with vermiculite or other inert material, then place in a container for chemical waste. Dike far ahead of larger spill for later recovery and disposal.

Notification Procedures: Prevent entry into waterways, sewer, basements or confined areas. Inform authorities if large amounts are involved.

Environmental precautions: Do not contaminate water sources or sewer. Prevent further leakage or spillage if safe to do so.
